- CPTED is **Crime Prevention Through Environmental Design**

## Benefits of CPTED

- Reduce crime and anti-social behaviour
- Often THE most cost-effective way to reduce crime
- Supports Community Safety Officers, Rangers, Police, Neighbourhood Watch and others 24/7 and when not on location
- Benefits increase over time
- Helps resolve 'difficult' or intractable community safety problems

Reduce crime by:

- Design of environment
- Community actions
- Culture

# COVID-19



- COVID-19 - new and highly contagious coronavirus illness
- Symptoms:
  - Shortness of breath or cough, with or without fever.
  - In some cases, severe pneumonia.
- Groups at higher risk of illness and death:
  - Aboriginal and Torres Strait Islander people 50 years and older with one or more chronic medical conditions
  - People 65 years and older with chronic medical conditions
  - People 70 years and older
  - People with compromised immune systems
- Can overload hospital systems and threaten whole of society

# COVID-19 Strategies



Primary strategies to slow infection or eradicate COVID-19

- Self-isolation (stay at home) and social distancing
- Hygiene (hand washing, avoid contact with others...)
- Prohibited activities and venues
- Restrictions on travel
- Support hospital system
- Financial relief for individuals and organisations
- New Police resources
- New laws (e.g. domestic violence, tracking, travel)

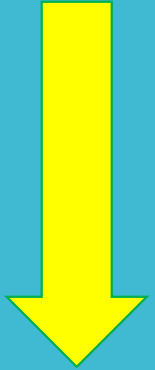

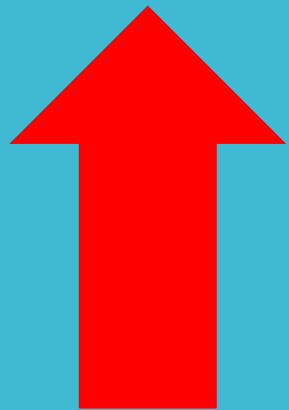

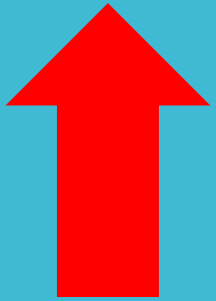

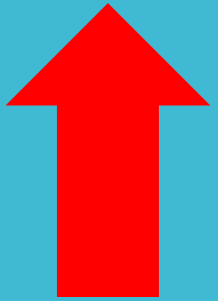


Non-residential

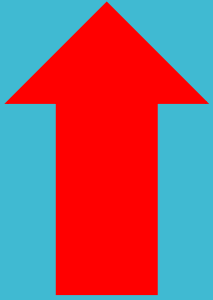
Theft for resale

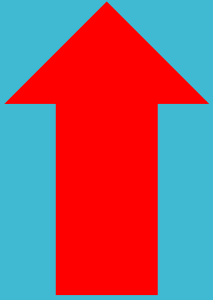

- Target hardening

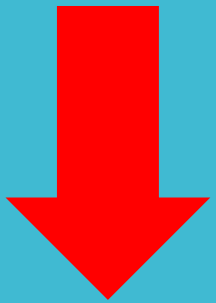
# The CULTURE PROBLEM and 'no one there' problem

CPTED and policing reduce crime through:

- culture
- habits of law-abiding public behaviour
- COVID-19 has broken cultural habits and reduced people in public space
- These changes require changes in the pattern of effective CPTED

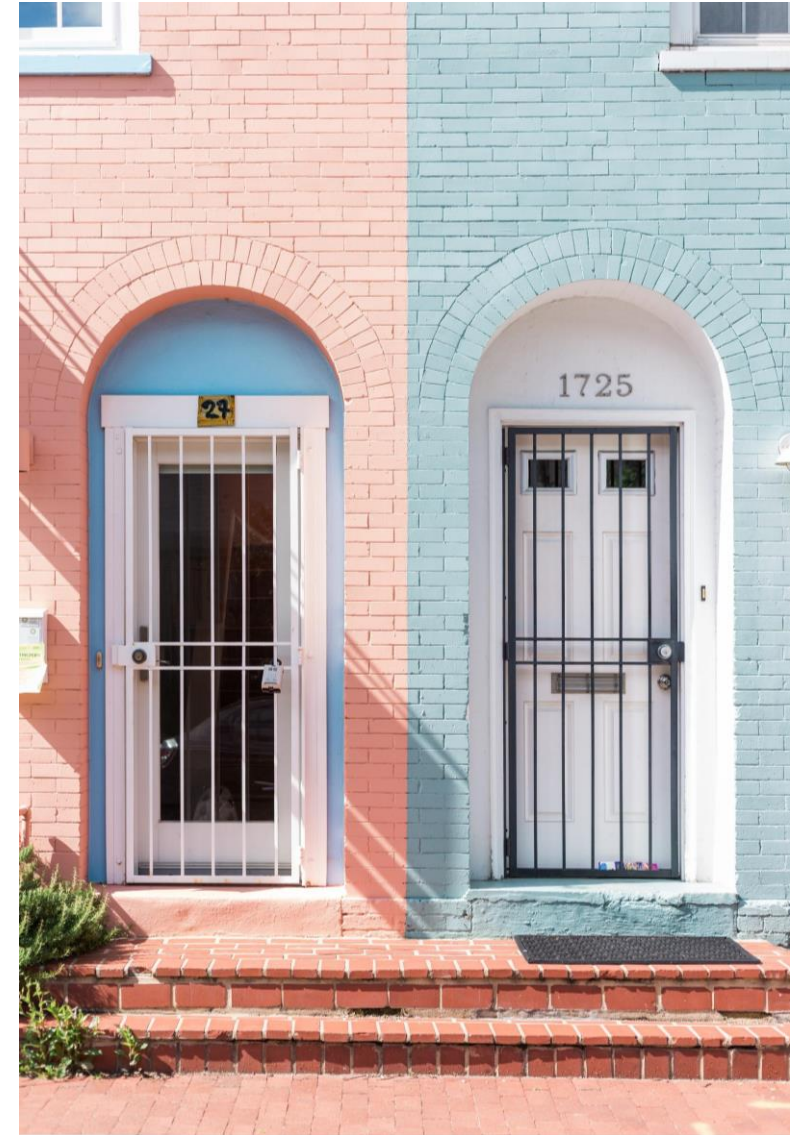


# Target Hardening

Effectiveness



- Increased physical security of valuable assets
- Increases the crime 'costs' in **time**, **effort** and **risk**
- 'Arms race' with criminals

# Effective CPTED during COVID-19

Effective CPTED during COVID-19 has different priorities:

1. Target hardening
2. Stopping repeat victimisation
3. Routine activity analysis
4. Image management and maintenance
5. Territorial reinforcement and defensible space
6. Natural surveillance ('eyes on the street')
7. Natural access control
8. Activity support

# Target hardening

- **Target hardening** important when other CPTED less effective
- Make crime more difficult and take more time.
- Conventional target hardening :
  - Strong doors, door frames and locks (preferably certified)
  - Security shutters
  - Defense in depth (e.g. securing internal garage doors, using a safe)
  - Secure perimeter
  - Blocking offensive surveillance
  - Ensuring eggs NOT in same basket...

# Stopping Repeat Victimisation

- Strongest predictor of crime is prior crime
- Crime risk highest immediately after crime
- Stopping repeat victimisation requires **visually-obvious protective changes**
- For **domestic violence** – new laws and processes apply. Specialists offer the best advice (1800 RESPECT 1800 737 732)



## Routine activity analysis

- Routine activities define crime
- Different routines in COVID-19
- Temporary cameras reveal activities in an area of interest – particularly at night or in remote areas
- This informs effective CPTED

# Image Management and Maintenance

- Well-kept locations reduce crime
- Presence of maintenance and cleaning staff :
  - Natural surveillance
  - Shows they are occupied
  - Indicates there are spare resources
- Effectiveness - **High** - frequently cleaned/maintained
- Effectiveness - **Low** - in-frequently cleaned/maintained

# Territorial reinforcement

- **Territorial reinforcement** defines:
  - Public space
  - Semi-public space
  - Semi-private space
  - Private space
- Indicates good behaviours and level response if violated (defensible space).
- Effectiveness – **High** in occupied locations
- Effectiveness - **Low** in un-occupied locations



# Natural Surveillance (‘eyes on the street’)

- **Natural surveillance** is less-effective when people at home on Netflix.
- Sightlines for ‘eyes on the street’ provide criminal surveillance.
- Legal street activities reported as ‘criminal/anti-social’
- Encourage public to only report crime.

# Natural Access Control

3 primary roles of **natural access control**:

- Visual signals to guide law-abiding persons
- Visual signals to support **territorial reinforcement**
- A basis for identifying and querying abnormal behaviours of people who don't follow the signs.

*When public space is empty, **natural access control** has less value.*

# Activity Support

- The aim of **Activity Support** is to encourage large numbers of people to a location to provide law-abiding 'eyes on the street'.
- COVID-19 protection strategies directly act against Activity Support
- One possibility is to use 'permitted activities' such as mobile food vans to provide activity support.

# ‘Shocks’ and Crime

- Criminal activity changes as a result of ‘shocks’ – bad weather, holidays, special events – COVID-19...
- ‘Shocks’ result in the **displacement** of crime in location, time and to different crimes.
- For COVID-19:
  - First crime **reduces**
  - Next **increases** past normal and changes crime types and locations
  - Settles down to crime rate before the ‘shock’ but in **changed places and for different crimes**.

# COVID-19 and risk of Law and Order breakdown

## COVID-19 related changes:

- Place pressures on vulnerable members of society
- Offer significant opportunities for ignoring the rule of law for personal benefit
- Current evidence of COVID-19 sporadic looting activities in countries including US, UK, Ireland, Italy, France and South Africa

## CPTED to support restoration of Law and Order

At this stage, the CPTED strategies to support restoration of Law and Order appear same priorities:

- Target hardening
- Stopping repeat victimisation
- Routine activity analysis
- Image management and maintenance
- Territorial reinforcement
- Natural surveillance ('eyes on the street')
- Natural access control
- Activity support

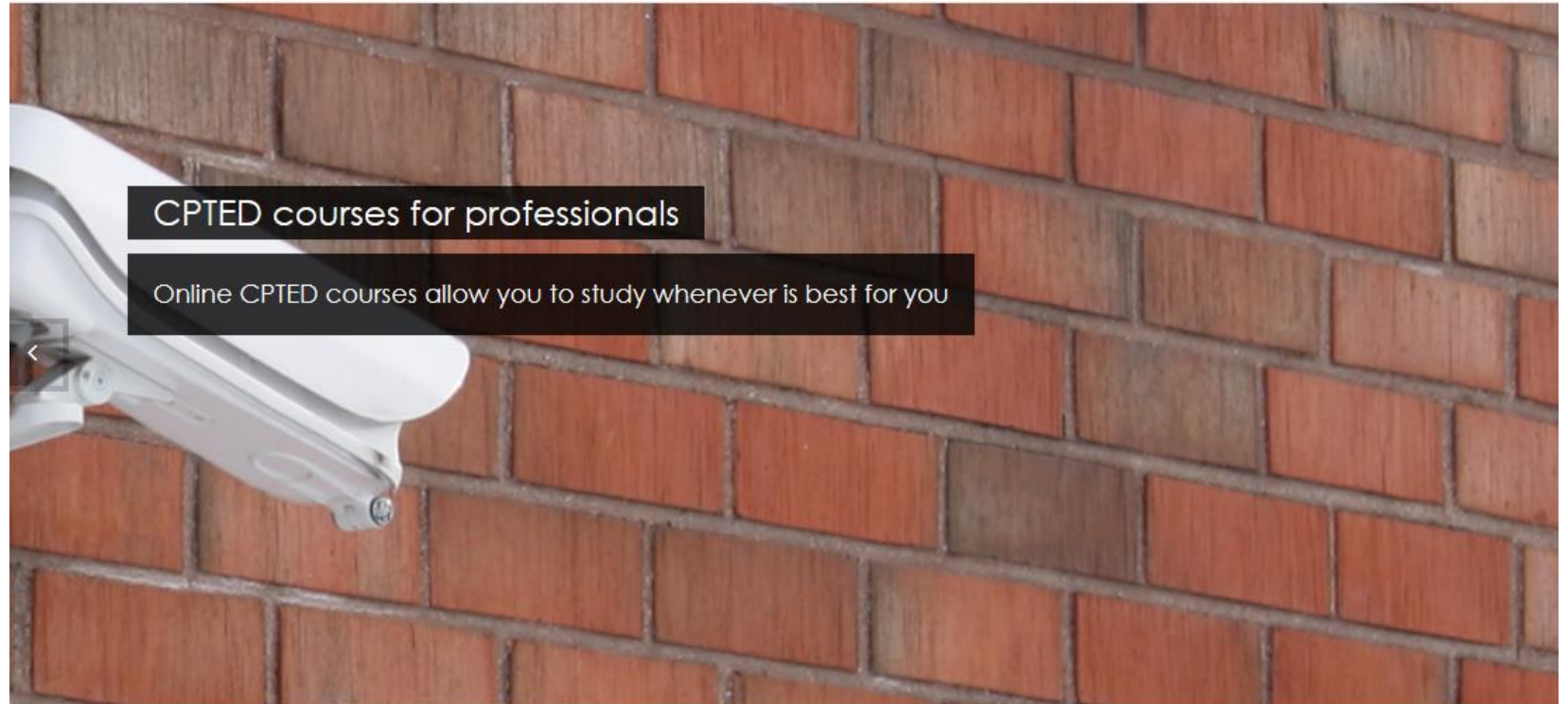

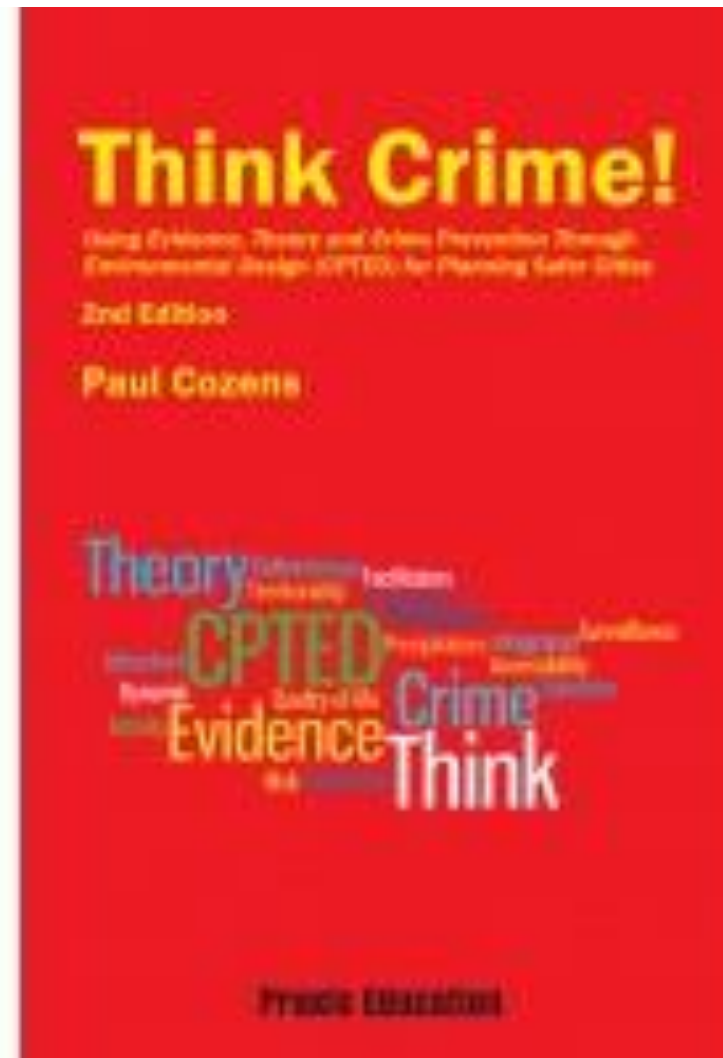
